## SDC MEET ADVENTURES OF JIM AND CAROL NICHOLS

An electric fuel pump will be installed to further ensure this can't happen again.

2. My 84 year old brother, Gene, flew up from St. Simon Island, GA to be with us for the week. Many years ago, he worked at Studebaker in the body drop building. I picked him up on Tuesday and we were having a great time until Thursday. In his haste to get to the vendor buildings, Gene fell off the bottom step of the tractor drawn shuttle and didn't think he was hurt. After judging, Carol and I headed up for lunch and then on to catch up with him. By then, he was hurting pretty badly and had seen the nurse at first aid. The nurse said she didn't think he had broken anything and gave him some over the counter pain pills. At that point, we folded up camp and headed for the hospital. Gene was carefully checked over and had x-rays taken. It was determined that he had a slight crack in a rib. All his vitals were just fine and all they could really do for him was give a prescription for two types of pain pills. I say stolen because I accidentally left it in the hallway while looking for our room. It was only a few minutes before I notice I didn't have it and hurried back to the spot. It was gone! Since it was never turned in, I consider it stolen. I did not want to lose my camera, of course, but the great loss was the chip in it with all the pictures taken the entire trip.

Other than that, we enjoyed the Meet and being with Carol's two sisters and all of their families and my brother. It was good to see our fellow North Georgia Chapter friends there as well. #

## DO YOU KNOW ABOUT THE STUDEBAKER NATIONAL FOUNDATION?

The Studebaker National Foundation is a non-profit public benefit Corporation to raise and provide funds for various charitable and educational purposes that are related to all aspects of Studebaker. One of its most outstanding programs is to award college scholarships ranging from \$250 to \$1000 to SDC members or members' sons/daughters and grandsons/granddaughters. The foundation has awarded over \$5300 in scholarships. In 2012, it awarded 4 scholarships. There were two fundraising events at the 2012 International SDC Meet: Specialty decorated shirts and jackets (shown below) were sold and the SDC auction raised \$4300.00.

# Scholarship Application

1. An SNF scholarship in the amount of \$250 up to \$1000 will benefit a member of the Studebaker Drivers Club, inc. (SDC), Antique Studebaker Club (ASC) or Avanti Owners Association International, (AOAI) as defined in #2.
2. The applicant must be a member or member's son/daughter, grandson/granddaughter of the SDC, ASC or AOAI for at least 3 years prior to the date of this application as confirmed by the organization's membership secretary.
3. Applicants from previous years may reapply.
4. The scholarship assistance may be used at an accredited school of the recipient's choice.
5. Full- and part-time students will be eligible for scholarship assistance.
6. Scholarship applicants must have obtained at least an equivalent of a 2.5 GPA on a 4.0 scale or equivalent for the year preceding the request for scholarship assistance. (High School transcripts - 2.5 on a 4.0 or equivalent).
7. Recipients must use the scholarship for the present or following school year. The award cannot be deferred.
8. Applicants must submit copies of all their academic transcripts and a teacher letter of recommendation with their application.
9. Completed applications must be submitted by May 1.
10. The following criteria will be used to select the scholarship recipient: grade point average (GPA); teacher letter of recommendation; and an evaluation of the answers provided to questions #15 and #16 below.
11. Proof of enrollment in an accredited college or school may be required after the scholarship has been awarded.
12. All decisions made by the Scholarship Committee regarding scholarship awards are final.
13. The successful candidate will be notified by August 1.
14. Scholarship money will be awarded to the college of choice after the first semester.

In the past it has been unclear to me who actually is on the list to receive these "Communiqués." Due to the sensitive nature of this one, I am copying each of you so you are aware of the resolution of this issue. For those of you who are not aware of the issues that precipitated the following messages, I'll share my (likely incomplete) understanding. As I understand it, SDC's election procedure for President relies on ten board members casting votes. However, by my understanding, there was no provision in the bylaws to deal with the possibility of a tie vote. After three votes, the incumbent president (Tom Curtis) withdrew his name from the running, apparently leaving the next president to be the other candidate (Ed Reynolds).

Ed Reynolds has withdrawn. His statement to the SDC Board of Directors follows. I have assumed the office of President and my comments sent to the Board are below. This will allow us to move forward and conduct the business of SDC. Please continue to contact your Zone Officers with your input and questions.

Unfortunately, sometimes in our pursuit of being "right" we get a bit carried away.

I think that it's time for us to do some long distance email hand shaking and acknowledge that mistakes have been made on both sides and that we're unified in being anxious to get SDC back on its feet again.

Please agree with me on this.

I will continue as a strong supporter of this club and encourage all of you to follow Carl's leadership in getting things back on track.

To let SDC members know that the question of the Presidency has now been resolved in accordance with our By-laws and that we are moving forward, I ask that the Director of each Zone forward this e mail, which includes Ed's statement and my comments, to their Zone Coordinators, requesting that they forward it to their Regional Managers with instructions to distribute the information to all Chapters in their respective regions. I will also post Ed's statement and my response on the Forum. This should ensure that the membership is aware of what is going on as quickly as possible without the delay of communicating the information in Turning Wheels.

In stepping aside, both presidential candidates involved in the undecided election have shown us that they want us to move past this negative time and work together for the benefit of the Studebakers Drivers Club.

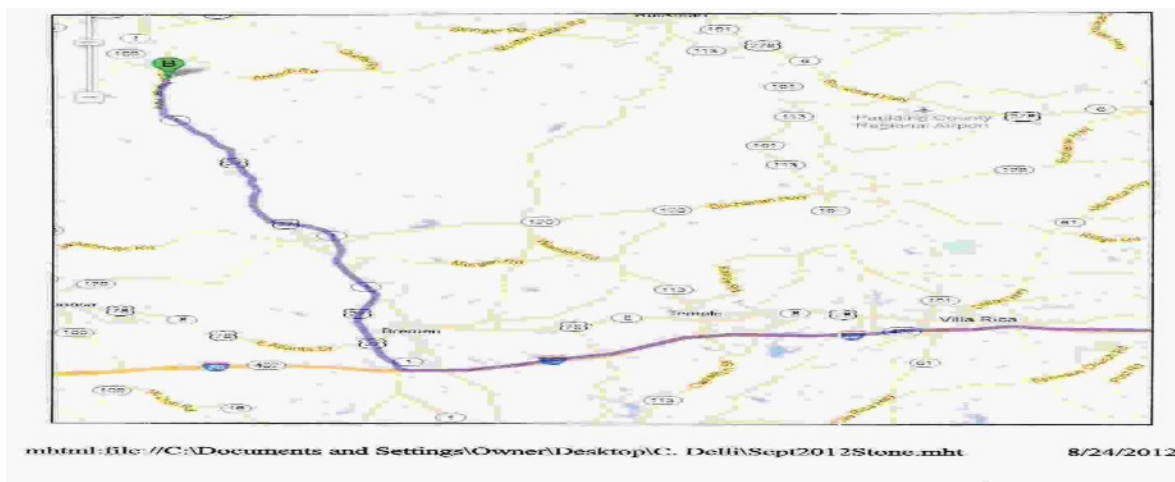
