EDITOR COMMENT

Once again, North Georgia Chapter member Ann Lee has done a superb job of putting together the North Georgia Meeting Schedule for 2016. (See Page 7.) Thank you, Ann, for stepping up and taking on a tough project. You gave the North Georgia Chapter a schedule that works in the Chapter's best interest.

And, once again, there was the dilemma of scheduling the September meeting while not knowing what the North Carolina Chapter SDC may or may not do about the Tri-state Meet.

Historically, the Tri-state Meet has been held each year, but there is no guarantee until it is announced officially. This did not happen in 2015 until the notice was published in the May 2015 issue of the *Turning Wheels* "What's Happening" section. We cannot wait until the middle of the meeting year to finalize the North Georgia schedule.

Traditionally, the North Georgia Chapter tries to hold meetings on the first weekend of the month. In September, this is not feasible because of Labor Day. Ideally, the meeting then would be held on the second weekend of the month. For reasons discussed later, holding the North Georgia September meeting on the third weekend of the month to accommodate what *may* happen in North Carolina is not in the best interest of the North Georgia Chapter. Waiting until the North Carolina Chapter publishes the date of the Tri-state Meet to set the North Georgia September meeting date also is not feasible. The question becomes "Does the North Georgia Chapter hold its meeting schedule hostage to the decision, or the failure to provide a timely notice, of another Southeast Zone Chapter?"

(I guess there is something about experiencing heart surgery with having my chest cracked wide open, my heart stopped completely and my life sustained on a heart-lung machine that makes me a little feisty.)

As the host of the September 2016 meeting, it is only fair to me to have the date firmly established early on instead of having to wait until a few short months before to finalize my planning. Some meetings may be as simple as engaging a nice restaurant; others may be a little more complicated when the host wants to throw a party. It takes time.

It is only fair to the Chapter's Newsletter Editor that the monthly meeting be held as early as possible in the month. This gives him the opportunity to publish the most current information before the end of the month. Since the newsletter contains meeting minutes, the Treasurer's report, and member information from the most recent meeting, it is paramount that the information be current. Getting all the information pulled together in the newsletter, too, takes time. Holding a meeting in the third weekend and expecting the newsletter in the very next week is not reasonable.

Better yet, why doesn't the North Carolina Chapter consider other chapters and schedule the Tri-state Meet for that third weekend in September? This frees other Southeast Zone Chapters to celebrate "Drive Your Studebaker Day" with their own events. North Georgia has a great 2016 meeting schedule and it should be celebrated! ###

ARE YOU A LAZY TRUCK OWNER?

I am kinda; especially when it comes to checking the brake fluid in my '59 truck. The truck has been in my possession for 12 years and it is getting harder to check that fluid every time I take the truck out. Maybe its because I am getting older, too.

This year, I finally decided to make a change --- add a remote master cylinder reservoir, which was actually an option back in the day. A billet reservoir kit from "Street Rods, Parts, and Memorabilia" (937-382-1871) located in Wilmington, Ohio was chosen. The cost was very reasonable at \$75.00. If interested, the company is easily located on the web.


The kit comes with a screw cap reservoir made of aluminum, aluminum mounting bracket, a woven stainless steel line for fluid transfer to the master cylinder, and a 90 degree fitting that permits the access to the master cylinder fill cap under the floor-board. The fill cap must be drilled and tapped to accept the fitting. Care must be taken to not damage or block the vent hole in the cap.

Now when I head out to the next show, I simply lift the hood and take a quick look!. The next time you see my truck, come on over and check out the new system. And, at the same time see my new "Motor Minder" gauge that will be the subject of my next article.

Note: Thanks Chris and Chuck for providing the reservoir cap that was drilled to accept the line fitting.





Written by Chuck Lampman, this 99 page book is based on articles written by Chuck Lampman, North Georgia Chapter SDC member, that appeared in *Turning Wheels* in the early 1990's and won the SDC Churchill Award for Best Article, Non-paid. Some material edited out of *Turning Wheels* is included in the book as well as updates and several new items written after the *Turning Wheels* series was published.

"Some Thoughts" is aimed at the first time restorer but will be of value to the

more experienced. It is not intended to be a "how to restore" book but gives a look at the decision-making processes, tools, spaces, and basic skills needed to do a restoration. It also provides a framework to help structure a project and contains several chapters of Studebaker-specific advice.
