## MEET YOUR NEW PRESIDENT

### WAYNE ZIEMER

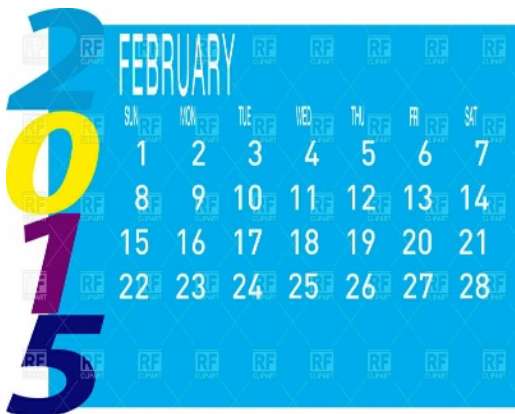

Wayne Ziemer is a relative newcomer to the Studebaker experience, but this does not keep him from being an enthusiastic supporter. He and his wife Terry, the North Georgia Chapter Recording Secretary, have been active in the North Georgia Chapter since they joined in 2010.

Driving a car of any kind did not come early in Wayne's life. Neither of his parents were drivers. As a teen, only one of his friends was interested in cars. His only exposure to Studebaker was one owned by the parents of a friend and that Studebaker's engine seized up. Wayne's first experience with driving was at age 17 when a neighbor offered to teach him to drive. Wayne hit a tree during the lesson and that was that.

Wayne did not get behind the wheel again until he was 22. Circumstances (no one to drive him around) forced Wayne to become a driver. He was in the US Army, stationed in Germany, at the time. He first earned a military driver's license by driving a 2 ½ ton truck, basically on instinct alone. (During the driving test, he did not even take the truck out of second gear.) The military license made him eligible for a German license by taking only a written test. After that, Wayne taught himself to drive by trial and error.

In the years that followed, Studebaker was not a part of Wayne's driving experience. Throughout the years before 2010, he owned Fiats, Buicks, Mazda's, Nissans and an Alfa Romeo. In 2010, Wayne became an "accidental" Studebaker owner. Intending to buy an old truck, Wayne started checking out vehicles on eBay. He happened to see a 1953 Studebaker Commander on an auction site. Not really serious and more as a lark, Wayne registered on the auction site and got an immediate approval. When the 1953 came up for bid, there were no bids. ## TECHNICAL TOPICS

(The following article, written by Chuck Lampman, is reprinted from the November 1987 issue of The Hillholder, the North Georgia Chapter newsletter, Chuck Lampman Editor.)

### CROSS FIRING

The firing sequences of most V-8 engines cause a peculiarity that can do significant damage to an engine; it occurs when the firing of one spark plug induces a current and a resulting spark in an adjacent plug wire on a cylinder which is almost, but not quite, at the top of the compression stroke. This can happen on any multi-cylinder engine when two adjacent plugs fire sequentially but the most common culprits are numbers 5 and 7, the last two cylinders on the driver's side on all Studebaker V-8s (and most GM and Chrysler cars) with a 1-8-4-3-6-5-7-2 firing order. Number 7 is firing while number 5 is 22 ½ degrees before top dead center; the result is a premature

firing of number 5, with a tremendous load on the piston, bearings, and crankshaft. This detonation is quite capable of pounding a hole in the top of a piston, or doing other damage. On the Packard engined 56J Golden Hawk I actually had the entire end of the cast-iron starter casing, the part that holds the Bendix drive, shear off when this problem spun the engine backward while cranking. The secret-**check your plug wires' routing** to maintain at least 1 ½ inches of distance between number 5 and number 7 wires. Studebaker actually did away with the plug wire carriers on the Packard engine in mid-year and replaced them with a much uglier one that spaces them about two inches apart.

### Coil Polarity

Another ignition item to check-correct coil polarity. Incorrect polarity will reduce firing voltage (and thus spark heat); although the engine will still run, firing voltage reduces by about 30 % at highway speeds, and will cost you gas mileage. Coil terminals are generally marked + and -; on negative ground cars the - coil terminal should be wired to the distributor, and on positive ground cars the + terminal is so wired. Remember that the points represent electrical ground to the coil so the terminal matching the car's ground goes to ground. If you're still in doubt about whether the polarity is correct, pull a plug wire and carefully hold the tip of a sharpened lead pencil between the plug wire and the plug top; the spark will cause a visible orange flare from the pencil point, which should go toward the plug.

All Studebakers since 1956 were 12V, negative ground—prior ones were 6V, positive ground, (though there is some confusion re' the very late 55s, some of which are reputed to have been built with 12 neg systems). The easy way to tell is that the fat post on the battery is always the positive; on a negative ground car you should be able to tract that cable to the starter or the starter solenoid.

### Ignition Drying Danger

Another quick ignition note—we have all used WD-40 to dry out wet ignitions on a car that won't start...we spray it liberally on the wires, plugs, cap, coil, and inside the cap. Did you know that a mist of WD-40 is relatively explosive? It's very volatile light oil, and inside a closed space like a distributor cap a spark from the ignition system can, and will, ignite it. Nearly cost me a new cap on the old Brand X about a month ago, produced quite a bang and a column of smoke. After you spray inside the cap, let the mist dissipate before you put the cap on and crank. If you ruin a cap, it'll probably be miles from the parts house on a rainy day.

## BUTTERMILK SALAD

(One of the highlights of the North Georgia Christmas Party was member Helen Nelson's Buttermilk Salad. Responding to many requests, the recipe for this beautiful and delicious salad is provided below.)

### INGREDIENTS

2 3 oz. Packages Orange Jello (if making this salad in the summer) **OR**  
2 3 oz. Packages Raspberry or Strawberry Jello (if making this salad in the winter.)  
20 oz. Can Crushed Pineapple with juice  
2 Cups Buttermilk  
8 oz. Kool Whip

### DIRECTIONS:

Cook pineapple and juice in a saucepan over medium heat. When it comes to a boil, stir in the 2 packages of Jello. Cook until Jello is dissolved. (Don't overcook.) Remove from heat and let cool to room temperature. Stir in 2 cups buttermilk. Let mixture sit a short while in the refrigerator. ( It will not be firm.)

Add Kool Whip and pour mixture into a serving bowl (9 by 13 inches). Refrigerate until set. Before serving, if desired, the salad can be topped with more Kool Whip and fruit or not.

Note: For lower calorie version, use sugar free Jello and low fat buttermilk. The salad served at the Christmas Party was not the low calorie version.

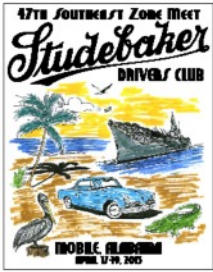

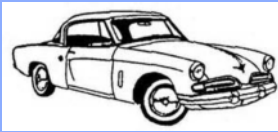

## STUDEBAKER MEDIA



### SOME THOUGHTS ON RESTORING A STUDEBAKER

Written by Chuck Lampman, this 99 page book is based on articles written by Chuck Lampman, North Georgia Chapter SDC member, that appeared in *Turning Wheels* in the early 1990's and won the SDC Churchill Award for Best Article, Non-paid. Some material edited out of *Turning Wheels* is included in the book as well as

updates and several new items written after the *Turning Wheels* series was published.

"Some Thoughts" is aimed at the first time restorer but will be of value to the more experienced. It is not intended to be a "how to restore" book but gives a look at the decision-making processes, tools, spaces, and basic skills needed to do a restoration. It also provides a framework to help structure a project and contains several chapters of Studebaker-specific advice.
