## Is it Ever Okay to Alter the Mileage Reading of a Car?

Reading the title of this article, you might think it will be a very short one since the answer is obviously "NO!" However, read on....

Every automaker has positives and negatives associated with their corporation and its products. Historians tell us that one of Studebaker's positives was the ethical foundation the corporation was built upon. The motto of the company when the original five Studebaker brothers ran the wagon manufacturing business was, "Always give more than you promise". This had much to do with their worldwide success as makers of wagons and later automobiles.

However, the corporation did have a surprising view of altering the mileage on used vehicles.

In the October 2003 issue of *Turning Wheels* there was an article about a man's childhood memories of a Studebaker dealership. As an adult, he made contact with the son of the former dealership owner. A story was recounted about seeing used cars at the dealership in South Bend with the odometers set back to all zeros. To quote directly from Page 7 of that issue:

**Ed remembers several trips to South Bend for "dealer driveaways" and recalled seeing used cars on the Freeman-Spicer lot (possibly Scherman-Schaus-Freeman at that time) showing odometers set at "00000.0" and advertised as "reconditioned like new"!**

Due to this article, I wrote a letter to the editor which was printed in the November 2003 issue of *Turning Wheels*. My letter, which is reprinted below, appeared on Page 27 under the heading of "Altered Odometers".

**I always enjoy *Turning Wheels*. The October 2003 issue was even better than usual. The Iowa to California diary by Peter Kneedler was most interesting.**

**I am almost never moved to write, but I must put in my two cents worth regarding the Studebaker Dealership article about Carl E. Filer Co. by Bill Pressler. In it he refers to Ed's recollection of going to South Bend for a "dealer driveaway" and seeing used cars at the Studebaker dealer's lot with odometers set back to zero and being referred to as "reconditioned like new". Well that paragraph rang a very dim bell with me and started me looking through my library.**

**It turns out that three years ago I purchased a 31 page booklet published by Studebaker in December, 1929, entitled, "How to Judge a Used Car". This booklet is aimed at the potential used car buyer.**

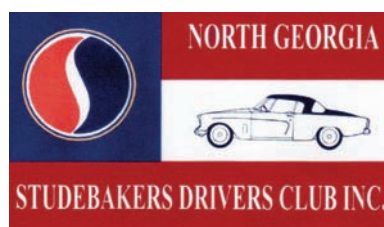
**Under the heading of, "As to Speedometers" it address the zeros miles issue. Interestingly, it uses the word "speedometer" where we would today use the word "odometer". This section of the booklet (pages 12 and 13) contains only two paragraphs, which read as follows:**

*Look for new miles -- not past ones. For your protection, reputable dealers ordinarily turn the speedometer on reconditioned cars back to zero. This prevents any unintentional misstatement for the speedometer might not tell a true story when the car comes into the dealer's possession. When a car has been so thoroughly reconditioned that it can be definitely guaranteed, it is logical that the speedometer should read "zero" for it is starting fresh to deliver a new owner new miles of satisfying service.*

*Speedometers get broken, or disconnected for a period of months, or are turned back several thousand miles before the car is traded in to the dealer. Reconditioning is of vastly greater importance than speedometer reading.*

**So there you have the Studebaker Corporation's thinking as of 1929, on the issue of turning speedometers back!**

### Old Business

2. The club has approximately \$1,400 for charitable use. The Finance Committee recommends that \$500 be sent to the Studebaker Museum Legacy of Studebaker Endowment Campaign, and that \$500 be sent to the "Lemay-America's Car Museum" in Tacoma, Washington to help fund the restoration of Avanti 1001. Lenny Major indicated he has contacted the museum about donating some of his Avanti parts to assist in the restoration of this historic car. Lenny also moved that we accept this recommendation of the Finance Committee; John Hollier seconded and the motion passed unanimously. The Finance Committee will wait a few months before recommending further contributions.
3. As mentioned last month, the club needs an editor for the newsletter.
4. In September we will meet on the second **Saturday** (the 10<sup>th</sup>) at **1:00 p.m.** at the Hot and Cold Buffet Restaurant at 2302 Main St East, Snellville, GA 30078. Restaurant telephone: (678) 344-5200. There will be a guest speaker.
5. In October and November the club will meet on the first **Saturday** instead of the first Sunday. This is October 1, and November 5. The meet on November 5 is a Mystery tour.

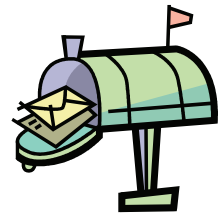

## Our Jump/Walk Shirts:

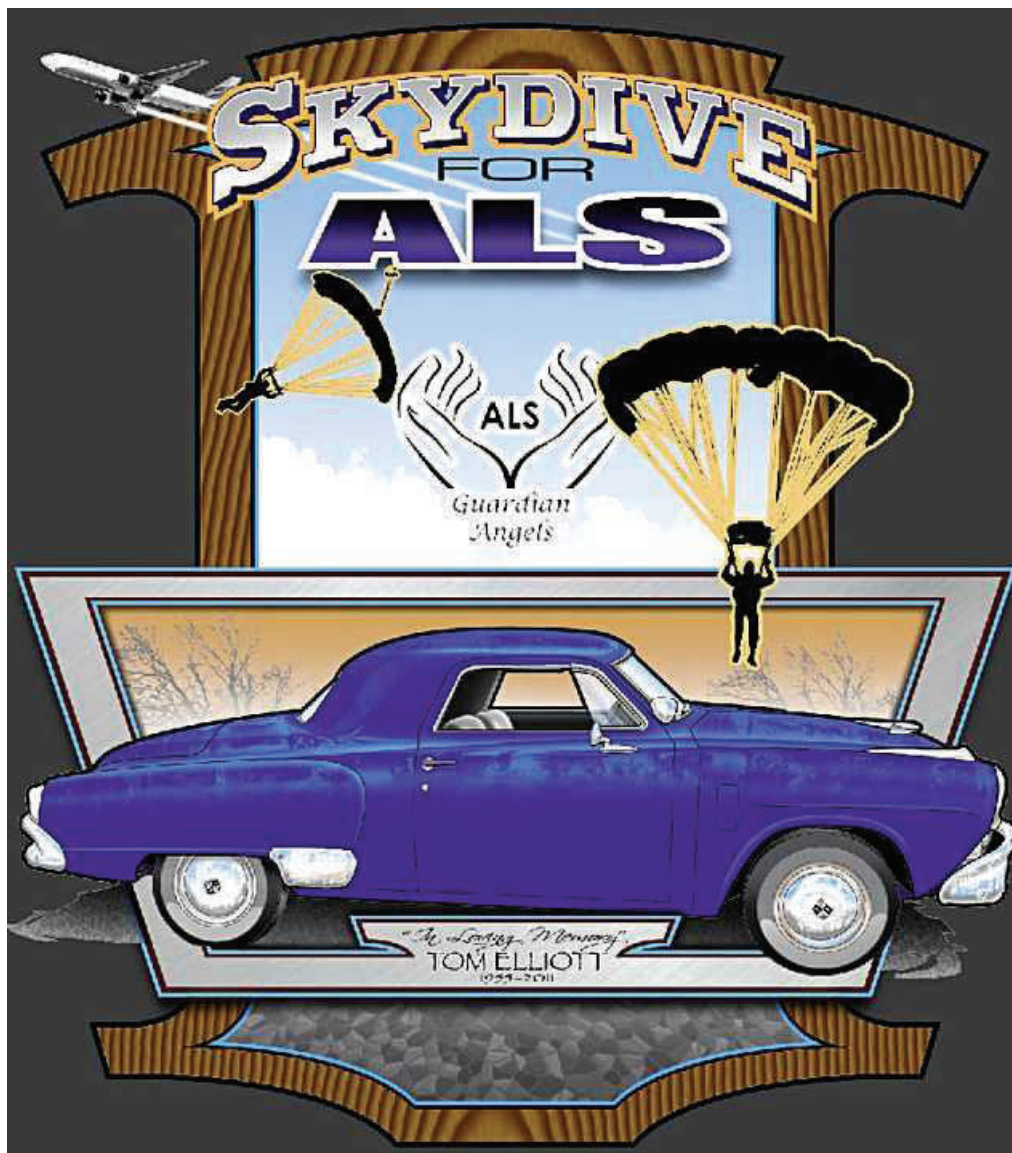

#### STUDEBAKER MEDIA



This is a 99 page book based on the articles of the same name that appeared in *Turning Wheels* in the early 1990s and which won the SDC's Churchill Award for Best Article, Non-Paid. The book contains all the material from the original series, which ran for a year and a half in *The Hillholder*, and not only replaces some material edited out for the *TW* series, but has updates and several new items that were written after the *TW* series was published.

"Some Thoughts" is aimed at the first-time restorer, but will be of value to the more experienced; it doesn't try to be a "how to restore a car book", but gives you a look at the decision-making processes, tools, spaces and basic skills you'll need to do a restoration, and will provide a framework to help you structure your project.

There are several chapters of Studebaker-specific advice. In the chapter devoted to engine rebuilding, I've tried to describe a step-by-step process that anybody can follow, and I've tried to include tips I've picked up in building 60+ engines. I've received many compliments on the engine chapter, and I'm glad to finally be able to get it in print.

*Some Thoughts on Restoring a Studebaker* is available for \$22.50 USD, plus \$4 for handling and postage, for a total of \$26.50 to US addresses. Canadian orders add \$6.50 USD for postage, total \$29.00 USD. To order a second book in the same order, add an additional \$3 (\$4 USD for Canadian orders). For Australia and Europe, shipping is \$12, total \$34.50 USD paid by PayPal only.
