Priorities

We all have priorities. Especially in difficult economic times, we hear a lot about people having to set priorities in order to be sure they have (and keep) what is most important or necessary. We've all done it at some point in our lives.

Sometimes however, we set priorities without realizing that is what we are doing. We are told that there are differences between "Baby Boomers" (those born between 1946 and 1964 when there was a sharp increase in the birthrate following World War II) and the next generations (Generation X and Generation Y). One of the most significant differences is that the Boomers naturally gravitated toward "deferred gratification". That is to say, they took on difficult tasks to help assure that things were better in the future rather than just living for the moment.

No, that description does not describe the Hippies. However, as those of us know who lived through the 1960's and 1970's, the vast majority of Baby Boomers were *not* Hippies. This is true despite what is portrayed in the news media and movies.

Prioritization is important to organizations as well as individuals. To get some insight into the priorities of an organization, a good place to look is in the Official By-Laws. The first paragraph of the By-Laws illustrates our organization's priorities. It reads:

“The name of this group shall be the North Georgia Chapter. *The purpose of this Chapter shall be to promote a closer relationship among owners of Studebaker and related vehicles in the North Georgia area; to encourage the acquisition, preservation and enjoyment of said vehicles; to promote expansion of membership*; and to provide and regulate social events, tours and exhibitions. The chapter will publish *The Hillholder* which will be the official publication of this chapter.”

In the above quote, I have taken the liberty of highlighting and italicizing part of the first paragraph of the By-Laws. When you read the highlighted part, it tells what our priorities are. In my opinion, these are good priorities. As we have all heard we come together because of our vehicles, but we stay together because of the people.

So the next question is, how do we strive to achieve our priorities? We meet in various locations monthly; share information about our vehicles; socialize; discuss club business etc. But in order to promote the welfare of our club, there too we have priorities.

In my mind, the single most important tool we have for pursuing the purposes of our organization is our newsletter, *The Hillholder*.

I say that for several reasons. First of all, it serves as a reminder of future activities. Second, it preserves our organizational memory. That is, in *The Hillholder* we document conversations held and decisions made. That is why I ask for a motion at each meeting to accept the minutes of the last meeting as published in the newsletter. The process of taking that vote is how we document that what was printed was actually what took place in our previous meeting.

However, by far the most important function of *The Hillholder*, is to keep **all** of our membership informed of what is going on in our chapter. We have many members we rarely see at meetings who only know what is going on in **their** club by reading the newsletter.

Please let me be clear, I am by no means saying anything negative about members who don't make it to many meetings. In my own case, I was very active in the club in the 1970's and early 1980's. Then in the latter part of the 1980's and through the 1990's I was not as involved. Family and career left me little time for attending club meetings and functions. However, it was very important to me to send in my dues each year and read the newsletter to keep up with what the chapter was doing. Several years into this new century, I retired and one of the first things I did was to again become active in the club.

During the time I was not active, I never lost sight of the fact that I was a member of this organization. When I again became an active member, I already knew what was going on.

The point here is that the newsletter is truly the life blood of the organization. As you read in the last newsletter, Chris Collins has let us know that he is ready for someone else to take over editing *The Hillholder* at the end of this calendar year. For four and a half years, Chris has done a wonderful, award-winning job and I know we all thank him. However, it is now time for someone else to step forward and take over this important activity. The next editor can personalize the newsletter as little or as much as he or she wishes.

Chris will gladly assist in assuring a smooth transition of these duties.

We can also consider creative alternatives, such as separating the duties of the Secretary from those of the Editor. If you have other ideas, just let me know. PLEASE do not simply continue on to the next article in this issue of *The Hillholder*. We need someone to step forward for the benefit of our chapter. It is our highest priority and in a very real sense the future of our club depends on it.

Until next time, let's remember to “throw out the clutch”.

North Georgia Chapter, Studebaker Drivers Club Meeting Minutes July 10, 2011

- President Alan Ziglin opened the meeting. Thank you to Rich Knoblock for hosting us today at The Flying Machine Restaurant. We welcomed Hobo and Brenda Bodkin's guest, Mickey Winling.
- Motion to approve the June meeting minutes as published in *The Hillholder* was made, seconded, and approved by all members present.
- We announced birthdays, anniversaries, and those members we need to keep in our thoughts and prayers.
- Edward Burris gave us a recap of the SDC Board Meeting held during the International Meet. The Meet hotel had a 1:00 AM tornado warning one night; thankfully, no threat materialized. Given his frequent travels to areas of the country prone to tornadoes, Ed brings along a weather band radio. His model costs around \$50, and automatically senses one's location in order to make the information relevant to the local area.

People who did not register for the meet were charged \$5 to enter the indoor parts sale area. A significant number of vendors disagreed with this practice, and some restricted their parts displays to the outside vending area because of it. Ed thinks that if we were to charge non-registrants for anything, it should be to attend to the seminars, not to look at parts.

Ed also mentioned that a new member roster was released during the Springfield Meet. Normally, the roster is revised every other year. However, since the supply of 2010-2011 rosters ran out, a new one was produced for 2011-2012.

- Pacific Southwest Zone Director Colin Fort sent a report on the International Meet to the presidents, editors, and regional managers in his Zone. Edward shared a copy with Chris Collins, and Chris will send it as a separate attachment with the next newsletter e-mail. If you receive *The Hillholder* by mail, contact Chris if you would like a copy of the report mailed to you. (At four pages, it is too detailed to fit into the newsletter.)
- Wayne Lee said the idea of all the Southeast Zone chapters contributing toward the host chapter's Zone Meet expenses did not get off the ground. Wayne also mentioned the Studebaker National Museum's car raffle. More information on that will be in *The Hillholder*.
- Charlotte Delli presented the Treasurer's Report; a copy will be in *The Hillholder*. Charlotte raised the issue of charging for replacement member name badges. After some discussion of pricing, Ben Alspach motioned that we charge \$10 for replacement badges. Charleen Carey seconded, and the motion was approved by all members present. We will continue to provide new members with complementary name badges.
- Bill Delli reports our membership count is steady at 66.
- The Chapter Finance Committee (Marsha Byrd, John Hollier, Chuck Lampman, and Alan Ziglin) prepared Guidelines for the Utilization of Extra Funds by the Chapter. These Guidelines will be printed in their entirety in *The Hillholder*. Based on member discussion, Items B and C (addressing Member Illness and Member Memorial Contributions) were extended to include a club member's immediate family. Janet Alspach made a motion that these Guidelines be approved as modified. Ed Burris seconded, and they were approved by the members present. The next step will be for the Committee to come back to the membership with specific suggestions for use of our current funds in excess of the \$5,000 minimum balance.
- Alan told us about the Adopt-A-Car program of the Studebaker National Museum. Under this program, organizations or individuals can "adopt" a vehicle in the museum's collection for one year. The program is designed to raise operating revenues for the Museum, which in turn can be used for care of the vehicles in the collection. There are four adoption tiers, with annual fees of \$100, \$250, \$500, and \$1,000. Most of the vehicles currently available for adoption are in the two priciest tiers. Alan learned that there is only one bullet nose Starlight Coupe Studebaker in the Museum, and it can be adopted for \$250 annually.

Motion was made to adopt the bullet nose for one year at \$250, in memory of Tom Elliott. The motion passed with one opposed vote.

- Barbara Miller told us about an effort to put together a Studebaker Authenticity Guide with year-and-model specific guidelines for use in the judging process. This was a topic at the membership meeting at the Springfield International Meet. Along with providing a basis for more accurate and consistent judging across the SDC, this endeavor would help to document some of the extensive Studebaker knowledge that our members collectively have.

The leaders of this project are seeking contributors to the guidelines. This may be something where our chapter can be of help. Dan Miller will contact the person leading the project, to find out what models have not yet been taken. More on this to come in future meetings.


- Barbara also presented Chris with the Senior 2nd Place award in the monthly internet newsletter category, presented in Springfield by the SDC Chapter Publications Committee.

- Hobo Bodkin told us he has sold his 1963 Avanti; the listing in *The Hillholder* was the only advertising he used.
- On August 27th, the ALS Guardian Angels Foundation will have a skydive in honor of Tom Elliott. The skydive will be in Rockmart, Georgia (east of Cedartown, south of Rome), with proceeds benefiting the Foundation. Unlike those groups which focus on ALS-related research and treatment, the Foundation helps ALS patients and their families deal with the immense burden the condition presents. Ways they assist can include helping someone obtain a wheelchair van, or by providing for caregiver costs or other living expenses. More information will be in *The Hillholder*.
- Alan called attention to our need for a replacement *Hillholder* editor for next year. The new editor can do the newsletter his or her own way; the current format in no way dictates how it should look in the future. Duties of the editor and the chapter secretary will be outlined in the newsletter. They are separate positions, and do not have to be done by one person.
- Billy and Charleen Carey were wearing their International Drive Your Studebaker Day (our September 10th meeting) t-shirts, and brought some for sale today. The shirts are blue with a State of Georgia outline, and the IDYSD logo. Price per shirt is \$6.50 for sizes small through extra-large; size XXL is \$8.50. As of July 12, Charleen has one Medium, four Large, and nine Extra-Large shirts remaining from her original order. She will bring what she has to the August meeting, and can order more if needed. - Speaking of the September meeting, we will start at 1:00 PM that day instead of the usual 2:00 PM. We have to be out of the restaurant by 4:00 PM that **Saturday** afternoon, and want to have plenty of time to accommodate our guest speaker's presentation on license plates.
- Next we drew for door prizes contributed by our host Rich. Winners included: Hellen Attaway, Brenda Bodkin, Chris Collins, Bill Delli, Pete McCaffrey, Carol Nichols, Jim Nichols, and our guest Mickey Winling.

June 25, 2011

The committee indicated that the guidelines to be presented to the membership for approval should be based upon the By-Laws of the Chapter and also should be created such that they will serve the Chapter well into the future, regardless of the Chapter's financial position at any point in time.

The following are the recommended Guidelines for the Utilization of Extra Funds by the Chapter:

- There are five categories of potential uses of these "excess" funds—Charitable; Member Illness; Member Memorial; Member Acknowledgements and Uses for the Benefit of the General Membership.
- The Chapter should always maintain a minimum balance of funds in the amount of \$5,000 in order to support future Meets it may sponsor or for other purposes.
- The \$5,000 limit may be waived in instances outlined in items B, C, D and E below.

Item A

CHARITABLE

- Charitable contributions may be made only to Studebaker-related causes.
- The Finance Committee will serve an advisory function overseeing charitable contributions. Any Chapter member in good standing may suggest charitable causes. The Committee will review the requests and submit their recommendations to the membership for their vote.
- Some illustrative examples which might be considered are:
 - the restoration fund for Avanti #1001 (see *Turning Wheels* June 2011, page 5);
 - the Studebaker Museum "Adopt-a-Car" program;
 - the Studebaker Museum "Legacy of Studebaker Endowment Campaign" (see *Turning Wheels* July 2011, page 12)

Item B

MEMBER ILLNESS

- Flowers or planters and such may be sent to members who are ill. The cost will normally be up to \$60 and this expenditure does not require approval of the membership.
- Contributions made in honor of a seriously ill member may be made to a charity supporting persons with that disorder by the Treasurer and President without approval by the membership.

For purposes of this section, "member" shall also include a chapter member's immediate family.

Item CMEMBER MEMORIAL CONTRIBUTIONS

--Contributions made in memory of a deceased member may be made in compliance with family's wishes and need not be Studebaker-related. These contributions may be made by the Treasurer and President without approval by the membership.

For purposes of this section, "member" shall also include a chapter member's immediate family.

Item DACKNOWLEDGEMENTS

--Acknowledgements of a member for outstanding merit, or other reasons, may be made by the Treasurer and President without approval by the membership.

Item EUSES FOR THE BENEFIT OF THE GENERAL MEMBERSHIP

--Excess funds may be used for the benefit of the general membership, upon approval by the Chapter membership. An example might be a catered Holiday meal at a December meeting paid for by the Chapter treasury and open to all members in good standing at no charge.

Chapter Secretary and Newsletter Editor Summary of Duties

Secretary

- Circulate a sign-up sheet at the monthly meetings, and pass it on to the editor afterwards.
- Record minutes of the membership meetings and submit them to the President, Vice-President, and Treasurer for review and approval prior to finalizing them. Give a copy of the finalized minutes to the newsletter editor for publication in *The Hillholder*.
- Answer chapter general correspondence, both e-mail and postal mail. This includes requests from members, as well as inquiries from outside parties. Redirect items to other chapter officers as appropriate.
- Maintain e-mail contact list of chapter members and share with the newsletter editor. Notify members regarding items of interest that arise between the monthly meetings. If an issue is of particular importance, then use phone calls or US Mail to inform those members without e-mail.
- At the end of the year, provide *Turning Wheels* editor with the calendar of meetings for the upcoming year, for inclusion in that magazine. Also provide any subsequent changes that occur.
- Annual chapter elections: Track nominations for office, and provide the editor with the official slate of officers so that formal notice of the election can be made in *The Hillholder* prior to the election in December. Report election results to the *TW* editor.
- The secretary also maintains the chapter By-Laws. Changes to the By-Laws are infrequent. The Secretary writes up the proposed change, provides the editor with the proposed text, and records the election results. If passed, then modify the official By-Laws, share them with the editor for publication in *The Hillholder*, and send a copy to the SDC Chartering Committee.

Newsletter Editor

- Take pictures at monthly meetings, and at other SDC-related functions when present. Also can use pictures supplied by other members (Ed Burris frequently helps me out along these lines.)
- Gather items to be included in the newsletter: photos, the President's message (Commander's Comments) and other submissions from officers, Treasurer's report, letters and notes submitted by members, event flyers, and other SDC-related information. Update the recurring features, such as birthdays, anniversaries, and remembrances. Have details for the next meeting on hand, including map and directions. Sometimes the host of the meeting provides this, other times I do it.
- Maintain the classified ads section. Insert new ad submissions, delete expired ones. Ads from chapter members generally run until the item is sold or the member chooses to drop the ad. Those from outside parties roll off after three months. Share ads with Chuck Lampman to ensure that the newsletter and the website have the same listings.
- Create the newsletter. I use Microsoft Publisher, since that is what Don Smith was using when I took his place as editor. There are other desktop publishing programs, but I have not tried them. One could use a word processing program such as Microsoft Word, but it might be less stable to work with unless the newsletter is fairly short in length. In Publisher, each page is like a blank canvas; you then insert text and photos into the layout. Individual parts can be moved around as you go along.
- Once the newsletter is complete, convert it to a PDF file. I use Adobe Acrobat, but there are other "PDF makers" also. PDF files are easy to view with the free Adobe Reader software. Another advantage of a PDF is that the content is "locked down" and cannot be altered or erased.
- I recommend sending the PDF on a draft basis to some "trusted readers" who will read it over and point out typos, sections where the meaning could be clearer, etc. I send it to the President, V-P, and Treasurer.
- After making any changes from the last step, again create a PDF and e-mail it to those members who use e-mail. For those without e-mail, make photocopies of the newsletter and take them to the post office.

Please feel free to contact me if you would like to learn more about these roles.

This is a 99 page book based on the articles of the same name that appeared in *Turning Wheels* in the early 1990s and which won the SDC's Churchill Award for Best Article, Non-Paid. The book contains all the material from the original series, which ran for a year and a half in *The Hillholder*, and not only replaces some material edited out for the *TW* series, but has updates and several new items that were written after the *TW* series was published.

"Some Thoughts" is aimed at the first-time restorer, but will be of value to the more experienced; it doesn't try to be a "how to restore a car book", but gives you a look at the decision-making processes, tools, spaces and basic skills you'll need to do a restoration, and will provide a framework to help you structure your project.

There are several chapters of Studebaker-specific advice. In the chapter devoted to engine rebuilding, I've tried to describe a step-by-step process that anybody can follow, and I've tried to include tips I've picked up in building 60+ engines. I've received many compliments on the engine chapter, and I'm glad to finally be able to get it in print.

Some Thoughts on Restoring a Studebaker is available for \$22.50 USD, plus \$4 for handling and postage, for a total of \$26.50 to US addresses.
